

OFFICIAL RULES FOR “Track Trivia at Auto Club Speedway”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: Track Trivia at Auto Club Speedway Sweepstakes (“Sweepstakes”) begins on December 6, 2015 at 12:01 a.m. Pacific Standard Time (“PST”) and ends on December 26, 2016 at 11:59 p.m. PST (the “Sweepstakes Period”).

Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. Limit one (1) entry per person, per day.
